### Footnotes

<sup>1</sup>Beginning in 2021, we will be ending our historic Senior rate category with a one-year transition provision available for eligible 2020 members.

As part of our transition to the new rate structure, 2020 members that renew their membership and qualify for Senior rates in 2021 are eligible to receive the Returning Senior rate. These Returning Senior members will continue to be eligible for this discounted rate category if their membership is renewed each year thereafter, without interruption. Should a Returning Senior miss a year, and rejoin a subsequent year, they would be considered as a new member and the Regular rate would be applicable. Returning Senior member rates are subject to future increases that may occur to Regular membership rates from time to time.

New members 65 years and older joining the club in 2021 and beyond will pay Regular rates. Current Regular members that turn 65 after 2021 will continue paying Regular rates.

<sup>2</sup>Family memberships include parents and children 18 years and less.

<sup>3</sup>Completed and signed Trail User Agreement is mandatory at the beginning of each new season.

### Payment Options (Cheque, eTransfer, VISA or Cash)

Cheques are payable to Seven Hills Golf & Country Club and can either be mailed (along with completed Application Form) to Box 1710, Port Hardy BC, V0N 2P0 or dropped off at the Pro Shop during operating hours.

#### E-TRANSFER INSTRUCTIONS:

1. Log into your online or mobile banking app and select the account for withdrawal.
2. Create Seven Hills as a recipient using the email sevenhills@live.ca
3. Enter the total amount with taxes (no need for a question as Interac e-Transfer® Autodeposit is set up).
- 4. Add a note with the name(s) of the member.**
5. Make sure the total amount you are sending corresponds with your membership application + services total.
6. Send e-transfer and mail in Member Application Form.

Payment by cash or VISA is possible at the Pro Shop however it is open weekends on a limited basis during the winter months. Please call in advance to confirm someone is there (250-949-9818).
