## Footnotes

<sup>1</sup>In 2021 we ended our historic Senior rate category. Senior members who renewed in 2021 were classified as Returning Seniors and will continue to qualify for the Returning Senior rate if they renew their membership annually without interruption. Should a Returning Senior skip a year and rejoin in a subsequent year, they lose their Returning Senior status and the Regular rate will be payable upon renewal. Current Regular members that turn 65 after 2021 will continue to pay Regular rates. New members 65 years and older joining the club after 2021 pay Regular rates.

<sup>2</sup>Family memberships include parents/guardians and children 18 years and younger.

<sup>3</sup>A completed and signed Trail User Agreement is mandatory at the beginning of each new season. Cart owners can designate a secondary user of their cart. All other users are expected to pay a \$10 fee to the club per use unless an Unlimited Cart User pass is purchased.

## Payment Options

Cheques are payable to Seven Hills Golf & Country Club and can either be mailed (along with completed Application Form) to Box 1710, Port Hardy BC, V0N 2P0 or dropped off at the Pro Shop during operating hours.

### E-TRANSFER INSTRUCTIONS:

1. Log into your online or mobile banking app and select the account for withdrawal.
2. Create Seven Hills as a recipient using the email sevenhills@live.ca
3. Enter the total amount with taxes (no need for a question as Interac e-Transfer® Autodeposit is set up).
4. Add a note with the name(s) of the member and indicate what you are paying for (e.g. Regular membership and locker).
5. Make sure the total amount you are sending corresponds with your membership application + services total.
6. Send e-transfer and mail in Member Application Form.

Payment by cash or credit card is possible at the Pro Shop however it is open weekends on a limited basis during the winter months. Please call in advance to confirm Dave is available (250-949-9818).

Payment by installments is available for membership fees only (not golf services). A 10% surcharge will be added to the total cost and included with the first installment. A signed agreement must be completed including credit card information. The Club will automatically process credit card payments as follows: 35% payable April 1<sup>st</sup>, 25% payable May 1<sup>st</sup>, 25% payable June 1<sup>st</sup> and final 25% payable July 1<sup>st</sup>.
